

## **Submission Requirements**

Open to only those who enter and who are 21 or older as of the date of entry. The competition is only open to legal residents of Arizona and is void where prohibited by law.

All participants must be an active bartender in an Arizona restaurant serving El Cristiano.

Drink Submissions must contain at least 1 ounce of El Cristiano tequila and not contain more than 6 ingredients. Any specialty ingredients must include a step by step recipe. If chosen, contestants will be asked to bring any specialty syrups, garnishes, etc. Contestant entries will be judged on creativity, presentation, uniqueness, approachability, and your written submission.

Contestants may enter the Agave Wars by filling out an online entry form through the Tradable Bits platform by visiting <a href="https://tradablebits.com/tb-app/508042">https://tradablebits.com/tb-app/508042</a>. Entry forms can be submitted through August 31, 2024. By filling out the online form, contestants will receive one (1) entry for consideration. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Gila River Resorts & Casinos. Limit one entry per person. More than one form entry can be submitted, but will still count as one (1) entry. Contestants may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. The first place winner will win a trip for 2 to the 2025 Tales of the Cocktails Event.
